SCOPE OF USE

Our toilet products, including suites, pans, cisterns, bidets and accessories, are designed for versatile use in various settings. They offer options for floor or wall mounting. Models feature different water inlet configurations, such as top rear, side, or bottom, ensuring compatibility with various plumbing setups. Engineered to enclose water efficiently, our products provide reliable performance and adaptability for diverse environments.

CONDITIONS OF USE

Toilets must be installed by a licensed plumber in accordance with AS/NZS 3500 and AS/NZS 6400 standards, on flat surfaces free of movement. For bidet seats, ensure High Hazard backflow prevention is installed (not supplied). The maximum working pressure is 500 kPa; if exceeded, a pressure-limiting valve must be used. The toilet pan should be firmly fixed to the floor with the supplied kit. The product is suitable for both domestic and commercial use, and is cleanable and impervious to moisture. Use soapy water or approved cleaners for maintenance; avoid abrasive materials.
